SUBJECT: **Regulation 6.150 Minimum Bankroll Requirements – Revisions to Formula**

The Nevada Gaming Control Board has revised the Minimum Bankroll Requirement formula, along with the accompanying General Overview and Instructions, as a result of recent amendments to Regulations 5, 5A and 22. The revised formula and related guidelines and instructions dated August 17, 2017, are available on the Board's website at <http://gaming.nv.gov>, for the following documents:

- Bankroll General Guidance
- Bankroll Instructions
- Bankroll Formula

The proposed revisions are denoted in the documents with deletions being shown with a strikethrough and additions being underlined.

Additionally, a new formula and accompanying instructions are being adopted to be used by licensee's whose gaming operations are primarily for the operation of a wide area progressive including a slot route operator (SRO) or operator of an inter-casino linked system (OILS). This new formula and instructions dated August 17, 2017, are also available on the Board's website for the following documents:

- Bankroll Formula – SRO OILS
- Bankroll Instructions Inter-Casino Linked Systems

These proposed revisions for wagering accounts and the new OILS formula are being published in accordance with Regulation 6.150(2). Any affected licensee may object to the proposed revisions by filing a request for a review of the Chairman's administrative decision,
