## 2018-04R: ADOPTION OF AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 1.155 REGARDING, WITHOUT LIMITATION, UPDATES TO DEFINED TERMS.

**PURPOSE**: To update the definition of registration to include other business entities in addition to corporations and to include registrations with the Board; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

## 2018-04R: ADOPTION OF AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 4.030 AND 4.080 REGARDING, WITHOUT LIMITATION, TIMING OF COMMISSION ACTION; AND REGISTRATION OF HOLDING COMPANIES.

**<u>PURPOSE</u>**: To specify when an act or involvement approved by the Commission has occurred or begun; to update the classification of Commission approved registrations of holding companies to include other business entities in addition to corporations; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

The proposed regulation changes will be considered by the Commission in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally.

These items will be heard by the Nevada Gaming Commission at the May 17, 2018 meeting, and may be continued and heard at subsequent meetings of the Nevada Gaming Commission as required to effectuate the above-stated purposes.
