2018-01R: AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 14 REGARDING,

WITHOUT LIMITATION: REGISTRATION OF MANUFACTURERS OF ASSOCIATED EQUIPMENT; AMEND THE PROCESS FOR APPROVING NEW GAMES; CORRECT THE DEFINITION OF ANTIQUE GAMING DEVICE; MISCELLANEOUS, NON-SUBSTANTIVE CORRECTIONS.

For Possible Action

<u>PURPOSE</u>: To amend the requirements relating to the registration of manufacturers of associated equipment; To make various non-substantive changes to make the regulation consistent with the numbering format, language, and reference style used in the Nevada Revised Statutes ("NRS") and Nevada Administrative Code; To replace language in regulatory definitions of terms that are also defined in the NRS with language that cites to the applicable statutory definitions; To provide a definition of "final action" as used in subsection 4 of section 14.025; To replace word "seriatim" with "serial" in paragraph (a) of subsection 2 of section 14.170 for consistency purposes; To add word "physical" before "size" in paragraph (b) of subsection 2 of section 14.170 for clarification purposes; To add the requirement relating to the operation and offering of associated equipment to section 14.260; To delete section 14.290, which requires approval to install associated equipment; To correct the definition of antique gaming device; And to take such additional actions as may be necessary and proper to effectuate this stated purpose.

The proposed regulation changes will be considered by the NGC in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally.

These items will be heard by the NGC at the December 20, 2018 meeting, and may be continued and heard at subsequent meetings of the NGC as required to effectuate the above-stated purposes.
