## For Possible Action

### **2019-03R: CONSIDERATION OF ADOPTION OF AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 6 REGARDING, WITHOUT LIMITATION, CALCULATION OF GROSS REVENUE.**

**PURPOSE:** In accordance with NRS 463.145, NRS 463.150, NRS 463.1595, and S.B. 46 passed during the 2019 Legislative Session, to amend Regulation 6.110(12)(a) and (c) to make the taking of certain deductions discretionary as opposed to mandatory; to create a new subsection (13) to Regulation 6.110 to provide for the calculation of gross revenue for contests and tournaments conducted in conjunction with a game or gaming device; to reformat certain non-substantive provisions in Regulations 6.110(12) and 6.120(3); and to take such additional action as may be necessary and proper to effectuate these stated purposes.

The proposed regulation changes will be considered by the NGC in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally.

These items will be heard by the NGC at the November 21, 2019 meeting, and may be continued and heard at subsequent meetings of the NGC as required to effectuate the above-stated purposes.
