2019-07R: CONSIDERATION AND RECOMMENDATION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 14 REGARDING, WITHOUT LIMITATION, REPORTING BY MANUFACTURERS AND DISTRIBUTORS.

PURPOSE: To amend Nevada Gaming Commission (Commission) Regulation by repealing subsection 6 of section 14.180, which requires that manufacturers and distributors submit annually to the Nevada Gaming Control Board (Board) a copy of the documentation evidencing registration with the United States Attorney General pursuant to the provisions of the Gaming Devices Act of 1962, 15 U.S.C. 1173; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

The proposed regulation changes will be considered by the NGC in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally.

These items will be heard by the NGC at the January 23, 2020 meeting, and may be continued and heard at subsequent meetings of the NGC as required to effectuate the above-stated purposes.
