**PURPOSE:** To consider amending Nevada Gaming Commission Regulations 5, 5A, 22, and 26C to create more regulatory uniformity for wagering account requirements between the different types of wagering that such accounts can be used for; to allow wagering accounts to be created entirely remotely or in person, including confirmation of an individual's identity, at the discretion of a licensee; to remove requirements that a patron personally appear before an employee of the licensee or employee of a book, as applicable, to confirm the patron's identity before being allowed to wager using a wagering account; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.
