**SUBJECT:** Licensee Workforce Vaccination Survey

The Nevada Gaming Control Board (Board) is assisting in the statewide effort to deploy the [COVID-19 Vaccination Program: Nevada's Playbook for Statewide Operations V3](#). This most recent version of the playbook includes Nevada's gaming industry as part of the state's "Frontline and Essential Workforce." To implement this portion of the Playbook most effectively, the Board is collecting information regarding the willingness of the industry's workforce to receive vaccinations.

The Board requires each nonrestricted licensee to complete the Licensee Workforce Vaccination Survey, found [here](#). This form will collect both licensee demographic information, as well as aggregate data based on each licensee surveying its workforce.

Completed forms must be submitted to the following email addresses based on a licensee's location:

Each licensee must submit its completed Licensee Workforce Vaccination Survey by 5:00pm on Thursday, January 21, 2021. While this effort is intended to be a service to the gaming industry, as well as to federal, state, and local health officials in planning vaccination programming, the gaming industry is deemed part of the State's critical economic infrastructure. Widespread vaccination of the industry's workforce is essential to the health, safety, and prosperity of the industry itself, its workforce, and to state and local government. Therefore, submission of the information is mandatory.
