2021-07R: NOTICE OF HEARING FOR CONSIDERATION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 4A.020 REGARDING, WITHOUT LIMITATION, TO UPDATE THE FEES FOR QUALIFIED ORGANIZATIONS WHICH OFFER PRIZES DURING A CALENDAR YEAR WITH A TOTAL VALUE OF LESS THAN \$100,000; AND TO TAKE SUCH ADDITIONAL ACTION AS MAY BE NECESSARY AND PROPER TO EFFECTUATE THIS STATED PURPOSE.

PURPOSE: To update the fees for qualified organizations which offer prizes during a calendar year with a total value of less than \$100,000; and to take such additional action as may be necessary and proper to effectuate this stated purpose.

The proposed regulation changes will be considered by the NGC in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally.

These items will be heard by the NGC at the September 23, 2021 meeting, and may be continued and heard at subsequent meetings of the NGC as required to effectuate the above-stated purposes.
