2024-01R: CONSIDERATION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 25 REGARDING, WITHOUT LIMITATION, TO REDUCE REPORTING REQUIREMENTS FOR ACTIVE AND TERMINATED INDEPENDENT AGENTS AND ADJUST RECORD-KEEPING OBLIGATIONS; AND TO TAKE SUCH ADDITIONAL ACTION AS MAY BE NECESSARY AND PROPER TO EFFECTUATE THESE STATED PURPOSES.

PURPOSE: To reduce the reporting requirements regarding currently active and terminated independent agents; to update the record keeping requirements in line with the reduction in reporting requirements; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

The proposed regulation changes will be considered by the NGC in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally.

This item will be heard by the NGC at the February 22, 2024 meeting, and may be continued and heard at subsequent meetings of the NGC as required to effectuate the above-stated purposes.
