DISCUSSION, AND POSSIBLE RECOMMENDATION TO THE NEVADA GAMING COMMISSION, OF AMENDMENTS TO NEVADA GAMING COMMISSION REGULATIONS 5 AND 7A REGARDING, WITHOUT LIMITATION, THE NON-PAYMENT OF WINNINGS TO INDIVIDUALS FORMALLY TRESPASSED FROM A GAMING ESTABLISHMENT OR TO INDIVIDUALS WHO HAVE BEEN PLACED ON NEVADA'S LIST OF EXCLUDED PERSONS.

i. PROPOSED NEW REGULATION 5.095

PURPOSE: In accordance with NRS 463.145, NRS 463.150, to create a new regulation regarding the non-payment of winnings to individuals formally trespassed from a gaming establishment or to individuals on Nevada's list of excluded persons; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

ii. PROPOSED AMENDMENTS TO REGULATION 7A

PURPOSE: In accordance with NRS 463.145, NRS 463.150, to exclude from the definition of "patron" any individual who falls within the provisions of subsection 1 of proposed new Regulation 5.095 which pertains to the non-payment of winnings to trespassed individuals and to individuals on the list of excluded persons; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

2. FOR POSSIBLE ACTION:

DISCUSSION, AND POSSIBLE RECOMMENDATION TO THE NEVADA GAMING COMMISSION, OF AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 14 REGARDING, WITHOUT LIMITATION, ENTITIES AND THEIR INTEREST IN INTELLECTUAL PROPERTY RIGHTS.

i. PROPOSED AMENDMENTS TO REGULATION 14

PURPOSE: To amend Nevada Gaming Commission ("NGC") Regulation 14.025(2) to allow entities or persons who have a good faith intention to acquire the rights to a theme to seek a determination from the Nevada Gaming Control Board Chair as to whether such theme is prohibited by NGC Regulation 14.025(1) – currently that ability is limited to entities or persons who already possess such rights; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.
