SUBJECT: 2024-05R: NOTICE OF HEARING FOR CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATIONS 5, 16, AND 22 REGARDING, WITHOUT LIMITATION, AMEND TEMPORARY ARMED SECURITY PERSONNEL REGISTRATION REQUIREMENTS; AMEND THE DEFINITION OF *PROSCRIBED ACTIVITY* TO MATCH STATUTORY LANGUAGE AND AMENDMENTS REGARDING REQUIREMENTS FOR BENEFICIAL OWNERS OF VOTING SECURITIES OF PUBLICLY TRADED COMPANIES; REQUIRE REPORTING OF WAGERS ON OUTCOMES WHICH HAVE ALREADY BEEN DETERMINED AND CLARIFY WHEN NEVADA GAMING CONTROL BOARD (BOARD) CHAIR APPROVAL FOR RESCISSION IS NECESSARY.

# 2024-05R: CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATION 5.102 REGARDING, WITHOUT LIMITATION, AMENDING TEMPORARY ARMED SECURITY PERSONNEL REGISTRATION REQUIREMENTS.

#### **PROPOSED AMENDMENTS TO REGULATION 5.102**

**PURPOSE:** To amend NGC Regulation 5 to align the process for applying for registration as a gaming employee for armed security personnel with the amended procedures of the Department of Public Safety; to clarify the acceptable documents for temporary registration of armed security personnel; to clarify qualifying records and their submission and maintenance; to clarify the time period for completion of registration of armed security personnel; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

### PROPOSED AMENDMENTS TO REGULATIONS 16.010 AND 16.405

# PROPOSED AMENDMENTS TO REGULATIONS 22.060 AND 22.115

**PURPOSE:** To require reporting when a sports pool or race book accepts an ostensible wager on an event whose outcome has already been determined; to clarify when approval from the Board Chair is necessary for rescission of a wager; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

All documents and material regarding these items are available at <u>https://gaming.nv.gov/regs/pending/regulation-activity/.</u> The proposed regulation changes will be considered by the NGC in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally.

These items will be heard by the NGC at the October 24, 2024 meeting, and may be continued and heard at subsequent meetings of the NGC as required to effectuate the above-stated purposes.
