<u>ORDER</u>

THIS MATTER came on specially for hearing before the Nevada Gaming Control Board

("Board") on November 1, 2023, and regularly for hearing before the Nevada Gaming

Commission ("Commission") on November 16, 2023, at Las Vegas, Nevada; and

THE BOARD AND COMMISSION having considered all information pertinent hereto;

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE

RECOMMENDATION OF THE NEVADA GAMING CONTROL BOARD:

1. THAT the following applications, as amended and supplemented, have been filed:

a. The application of the Mohegan Tribal Gaming Authority, dba Mohegan for registration as a holding company.

2. THAT the Mohegan Tribe of Indians of Connecticut, federally recognized as a sovereign nation in March 1994, established the Mohegan Tribal Gaming Authority in July 1995, that Mohegan Tribal Gaming Authority, dba Mohegan is substantially the same as, and shall for the purposes of this Order be considered a "holding company," as defined by NRS 463.485, that knowingly and voluntarily consents to, and shall be subject to, the jurisdiction of the Board and

Commission in the same manner and fashion as any corporate entity registered before the Commission would as a holding company.

3. THAT Mohegan Tribal Gaming Authority, dba Mohegan is registered as a holding company and is found suitable as the sole member and manager of MGNV Holding, LLC.

4. THAT Ralph James Gessner Jr., Sarah Elizabeth Harris, Thayne Douglas Hutchins Jr., Joseph Michael Soper, John Gerry Harris, William Quidgeon Jr., Kenneth Raymond Davison, and Mark Francis Brown are each found suitable as controlling persons of Mohegan Tribal Gaming Authority, dba Mohegan.

5. THAT MGNV Holding, LLC registered as an intermediary company and is licensed as sole member of MGNV, LLC.

6. THAT MGNV, LLC, dba Mohegan Sun Casino Las Vegas, is licensed to conduct off-track pari-mutuel race wagering and nonrestricted gaming operations, including a race book and sports pool, is licensed to operate a gaming salon, and is licensed as a manufacturer and distributor, at 4455 Paradise Road, Las Vegas subject to such conditions or limitations as may be imposed by the Commission.

7. THAT BetFred Sports (Nevada) LLC is licensed as a key employee of MGNV, LLC, dba Mohegan Sun Casino Las Vegas, and approved to receive a percentage of gaming revenue from the race book and sports pool, including off-track pari-mutuel race wagering, operated by MGNV, LLC, dba Mohegan Sun Casino Las Vegas, subject to such conditions or limitations as may be imposed by the Commission.

8. THAT Mohegan Tribal Gaming Authority, dba Mohegan is granted approval, pursuant to NRS 463.5733 and NGC Regulations 15B.180 and 8.030, to pledge its membership interest in MGNV Holding, LLC, to Citizens Bank, N.A., as Collateral Trustee, in conjunction with a Credit Agreement dated January 26, 2021 (as amended, supplemented, increased, extended, renewed, amended and restated or otherwise modified from time to time), provided that:

a. This approval is pursuant to a First Lien Pledge Agreement with Citizens Bank, N.A., as Collateral Trustee, dated January 26, 2021;

b. The prior approval of the Commission must be obtained before any foreclosure or transfer of any possessory security interest in such membership interest (except back to Mohegan Tribal Gaming Authority, dba Mohegan) and before any other resort to the collateral or other enforcement of the security interest in such membership interest may occur; and

c. Pursuant to NGC Regulations 15B.140 and 8.030(4)(a), the membership certificates, if certificated, of MGNV Holding, LLC, if any, evidencing said pledge of the membership interest must at all times remain physically within the State of Nevada at a location designated to the Board and must be made available for inspection by agents or employees of the Board immediately upon request during normal business hours.

9. THAT MGNV Holding, LLC is granted approval, pursuant to NRS 463.5733 and NGC Regulation 8.030, to pledge its membership interest in MGNV, LLC, to Citizens Bank, N.A., as Collateral Trustee, in conjunction with a Credit Agreement dated January 26, 2021 (as amended, supplemented, increased, extended, renewed, amended and restated or otherwise modified from time to time), provided that:

a. This approval is pursuant to a First Lien Pledge Agreement with Citizens Bank, N.A., as Collateral Trustee, dated January 26, 2021;

b. The prior approval of the Commission must be obtained before any foreclosure or transfer of any possessory security interest in such membership interest (except back to MGNV Holdings, LLC) and before any other resort to the collateral or other enforcement of the security interest in such membership interest may occur; and

c. Pursuant to NGC Regulations 15B.140 and 8.030(4)(a), the membership certificates, if certificated, of MGNV, LLC, if any, evidencing said pledge of the membership interest must at all times remain physically within the State of Nevada at a location designated

to the Board and must be made available for inspection by agents or employees of the Board immediately upon request during normal business hours.

10. THAT the fully executed First Lien Pledge Agreement shall not be amended without the prior administrative approval of the Board's Chair, or the Chair's designee. Such administrative approval may not be granted regarding amendments to the First Lien Pledge Agreement that increase or change the membership interest that is the subject of the pledge, or that change the identity of the Collateral Trustee.

11. THAT Mohegan Tribal Gaming Authority, dba Mohegan is granted approval, pursuant to NRS 463.5733 and NGC Regulations 15B.180 and 8.030, to pledge its membership interest in MGNV Holding, LLC, to Citizens Bank, N.A., as Collateral Trustee, in conjunction with the 8.000% Second Priority Senior Secured Notes dated January 26, 2021; provided that:

a. This approval is pursuant to a Second Lien Pledge Agreement with Citizens Bank, N.A., as Collateral Trustee, dated January 26, 2021;

b. The prior approval of the Commission must be obtained before any foreclosure or transfer of any possessory security interest in such membership interest (except back to Mohegan Tribal Gaming Authority, dba Mohegan) and before any other resort to the collateral or other enforcement of the security interest in such membership interest may occur; and

c. Pursuant to NGC Regulations 15B.140 and 8.030(4)(a), the membership certificates, if certificated, of MGNV Holding, LLC, if any, evidencing said pledge of the membership interest must at all times remain physically within the State of Nevada at a location designated to the Board and must be made available for inspection by agents or employees of the Board immediately upon request during normal business hours.

12. THAT MGNV Holdings, LLC is granted approval, pursuant to NRS 463.5733 and NGC Regulation 8.030, to pledge its membership interest in MGNV, LLC, to Citizens Bank,

N.A., as Collateral Trustee, in conjunction with the 8.000% Second Priority Senior Secured Notes dated January 26, 2021; provided that:

a. This approval is pursuant to a Second Lien Pledge Agreement with Citizens Bank, N.A., as Collateral Trustee, dated January 26, 2021;

b. The prior approval of the Commission must be obtained before any foreclosure or transfer of any possessory security interest in such membership interest (except back to MGNV Holdings, LLC) and before any other resort to the collateral or other enforcement of the security interest in such membership interest may occur; and

c. Pursuant to NGC Regulations 15B.140 and 8.030(4)(a), the membership certificates, if certificated, of MGNV, LLC, if any, evidencing said pledge of the membership interest must at all times remain physically within the State of Nevada at a location designated to the Board and must be made available for inspection by agents or employees of the Board immediately upon request during normal business hours.

13. THAT the fully executed Second Lien Pledge Agreement shall not be amended without the prior administrative approval of the Board's Chair, or the Chair's designee. Such administrative approval may not be granted regarding amendments to the Second Lien Pledge Agreement that increase or change the membership interest that is the subject of the pledge, or that change the identity of the Collateral Trustee.

14. THAT Mohegan Tribal Gaming Authority, dba Mohegan shall establish and maintain a gaming compliance program for the purpose of, at a minimum, performing due diligence, determining the suitability of relationships with other entities and individuals, and to review and ensure compliance by Mohegan Tribal Gaming Authority, dba Mohegan, its subsidiaries and any affiliated entities, with the Nevada Gaming Control Act (the "Act"), as amended, the Commission's Regulations (the "Regulations"), as amended, and the laws and regulations of any other jurisdictions in which Mohegan Tribal Gaming Authority, dba Mohegan, its subsidiaries and any affiliated entities may conduct gaming operations. The gaming

compliance program, any amendments thereto, shall be administratively reviewed and approved by the Board's Chair, or the Chair's designee, and the members of the compliance committee, one such member who shall be independent and knowledgeable of the Act and Regulations, shall be administratively reviewed and approved by the Board's Chair, or the Chair's designee. Mohegan Tribal Gaming Authority, dba Mohegan, shall amend the gaming compliance program, or any element thereof, and perform such duties as may be assigned by the Board's Chair, or the Chair's designee, related to a review of activities relevant to the continuing qualification of Mohegan Tribal Gaming Authority, dba Mohegan, under the provisions of the Act and Regulations.

15. THAT Mohegan Tribal Gaming Authority, dba Mohegan, maintain with the Board a revolving fund in the amount of \$50,000 for the purpose of funding investigative reviews by the Board for compliance with the terms of this Order. Without limiting the foregoing, the Board shall have the right, without notice, to draw upon the funds of said account for the payment of costs and expenses incurred by the Board and its staff in the surveillance, monitoring and investigative review of all activities of Mohegan Tribal Gaming Authority, dba Mohegan, its subsidiaries and any affiliated entities.

16. THAT Mohegan Tribal Gaming Authority, dba Mohegan shall comply with NRS 463.585 through NRS 463.615, inclusive.

17. THAT, pursuant to NRS 463.1665, Mohegan Tribal Gaming Authority, dba Mohegan shall comply with NGC Regulation 15, its subsidiaries and any affiliated entities shall comply with NGC Regulation 15B.
