ORDER OF REGISTRATION

THIS MATTER came on regularly for hearing before the State Gaming Control Board ("Board") on March 6, 1996, and before the Nevada Gaming Commission ("Commission") on March 21, 1996, at Las Vegas, Nevada; and

THE BOARD AND COMMISSION having considered all information pertinent hereto;

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE

RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

- 1. THAT the following applications, as amended and supplemented, have been filed:
- a. The applications of American Wagering, Inc. for registration as a publicly traded corporation and for approval of a public offering of equity.
- b. The application of Victor John Salerno, Jr. for a finding of suitability as a shareholder and controlling shareholder of American Wagering, Inc.
- c. The application of B-P Gaming Corporation dba Howard Johnsons on Tropicana to conduct nonrestricted gaming operations (slot machines, race book and sports

pool only) at Howard Johnsons on Tropicana, 3111 West Tropicana Avenue, Las Vegas, Nevada.

- d. The application of Leroy's Horse and Sports Place to conduct nonrestricted gaming operations (race book and sports pool only), dbat Stratosphere Tower, Casino and Hotel, 2000 Las Vegas Boulevard South, Las Vegas, Nevada.
- 2. THAT American Wagering, Inc. is registered as a publicly traded corporation and is found suitable as the sole shareholder of Leroy's Horse and Sports Place.
- THAT American Wagering, Inc. is found suitable as a 50% shareholder of B-P
 Gaming Corporation.
- 4. THAT Leroy's Horse and Sports Place is licensed to conduct nonrestricted gaming operations (race book and sports pool only) at the following locations, subject to such conditions or limitations as may be imposed by the Commission:

5. THAT Leroy's Horse and Sports Place is licensed to conduct nonrestricted gaming operations (sports pool only) at the following locations, subject to such conditions or limitations as may be imposed by the Commission:

Bonanza Casino, 4760 North Virginia Street, Reno; Bourbon Street Hotel and Casino, 120 East Flamingo Road, Las Vegas; Cactus Pete's, Highway 93, Jackpot; Comstock Hotel and Casino, 200 West Second Street, Reno; Continental Hotel and Casino, 4100 Paradise Road, Las Vegas;

Ellis Island Casino, 4178 Koval Lane, Las Vegas: Fitzgeralds' Casino Hotel, 301 East Fremont Street, Las Vegas; Frontier Hotel & Gambling Hall, 3120 Las Vegas Boulevard South, Las Vegas; Hotel San Remo, Las Vegas, Casino and Resort, 115 East Tropicana. Las Vegas; King 8 Hotel and Gambling Hall, 3330 West Tropicana Avenue, Las Vegas; Leroy's Horse & Sports Place, 114 South First Street, Las Vegas; Mahoney's Silver Nugget, 2140 Las Vegas Boulevard North, Las Vegas; Nevada Landing, Interstate 15, Las Vegas; Nevada Palace Hotel and Casino, 5255 Boulder Highway, Las Vegas; Parker's Model T Casino, 1130 West Winnemucca Boulevard, Winnemucca; Peppermill Inn and Casino, Interstate 80, Wendover; Riviera Hotel & Casino, 2901 Las Vegas Boulevard South, Las Vegas; Sand's Regency and Mr. C's, 345 North Arlington, Reno; Si Redd's Oasis Resort Hotel Casino, 1134 West Mesquite Boulevard, Mesquite: Skyline Restaurant & Casino, 1741 North Boulder Highway, Henderson; Tahoe Biltmore Lodge, Highway 28, Crystal Bay; Triple J Bingo, 725 South Racetrack Road, Henderson;

- 6. THAT Leroy's Horse and Sports Place is licensed to conduct nonrestricted gaming operations (race book and sports pool only), dbat Stratosphere Tower, Casino and Hotel, 2000 Las Vegas Boulevard South, Las Vegas, Nevada.
- 7. THAT B-P Gaming Corporation, dba Howard Johnsons on Tropicana is licensed to conduct nonrestricted gaming operations (slot machines, race book and sports pool only) at Howard Johnsons on Tropicana, 3111 West Tropicana Avenue, Las Vegas, Nevada.
- 8. THAT Victor John Salerno, Jr., is found suitable, pursuant to NRS 463.643, and NGC Regulation 16.400, as a shareholder and controlling shareholder of American Wagering, Inc.
- 9. THAT American Wagering, Inc. is hereby granted approval, pursuant to NGC Regulation 16.110, to make a public offering of up to 2,587,500 shares of Common Stock, \$0.01 par value per share, as more fully described in the Securities and Exchange Commission ("SEC") Form SB-2 Registration Statement, as amended (SEC Registration No. 33-80431) ("Registration Statement").
 - 10. THAT the approval set forth in paragraph 9 is specifically conditioned as follows:

- a. That American Wagering, Inc. shall keep the Board's Corporate Securities

 Division continuously and promptly informed as to the progress of the public offering and as to
 any other event that may have a material effect on American Wagering, Inc. or its subsidiaries,
 which would be subject to reporting on SEC Form 8-K; and
- b. That the approval granted herein may be rescinded without prior notice upon issuance of an interlocutory stop order by the Chairman of the Board. Said interlocutory stop order, if issued, shall remain in effect until it is lifted by the Commission upon such terms as are satisfactory to the Commission.
- 11. THE Commission hereby delegates to the Chairman of the Board the authority to issue interlocutory stop orders for good cause, which shall remain in effect until lifted by the Commission as provided in paragraph 10(b).
- 12. THAT American Wagering, Inc. is granted sixty (60) calendar days from the date of this Order of Registration to have the Registration Statement declared effective by the SEC. If the Registration Statement is not declared effective by the SEC within said time period, unless administratively extended by the Chairman of the Board or his designee, then this Order of Registration and all of the approvals, terms and provisions herein shall be deemed withdrawn and rendered null and void.
- 13. THAT American Wagering, Inc. shall establish and maintain a compliance committee for the purpose of, at a minimum, performing due diligence, determining the suitability of relationships with other entities and individuals, and to review and ensure compliance by American Wagering, Inc., its subsidiaries and any affiliated entities, with the Nevada Gaming Control Act ("the Act"), as amended, the Commission's Regulations, as amended (the "Regulations"), and the laws and regulations of any other jurisdictions in which American Wagering, Inc., its subsidiaries and any affiliated entities operate. The compliance committee plan, any amendments thereto, and the members, one such member which shall be independent, shall be administratively reviewed and approved by the Chairman of the Board, or

his designee. Furthermore, upon request of the Chairman of the Board, or his designee,
American Wagering, Inc., shall amend the compliance committee plan, or any element thereof,
and perform such duties as may be assigned by the Chairman of the Board, or his designee
related to a review of activities relevant to the continuing qualification of American Wagering,
Inc., under the provisions of the Act and Regulations.

- 14. THAT American Wagering, Inc. shall fund and maintain with the Board a revolving fund in the amount of \$10,000 for the purpose of funding investigative reviews by the Board for compliance with the terms of this Order of Registration. Without limiting the foregoing, the Board shall have the right, without notice, to draw upon the funds of said account for the payment of costs and expenses incurred by the Board and its staff in the surveillance, monitoring and investigative review of all activities of American Wagering, Inc., its direct and indirect subsidiaries, and their affiliated companies.
- 15. THAT, pursuant to NRS 463.625, American Wagering, Inc. is exempted from compliance with NRS 463.585 through NRS 463.615, inclusive and shall instead comply with NRS 463.635 through 463.645, inclusive.
- 16. THAT American Wagering, Inc. is exempted from NGC Regulation 15 and shall instead comply with NGC Regulation 16.
- 17. THAT the Commission hereby expressly finds that the exemptions granted hereinabove are consistent with the State policy set forth in NRS 463.0129 and NRS 463.489. ENTERED at Las Vegas, Nevada, this 21st day of March, 1996.
