11 O R D E R

12 THIS MATTER having come on regularly for hearing before
13 the State Gaming Control Board at Carson City, Nevada on August 18
14 and August 26, 1976, and before the Nevada Gaming Commission at
15 Carson City on August 26, 1976; Sam W. Klein and Bally Manufactur-
16 ing Corporation having consented to the entry of an Order in this
17 matter and thereby having waived any objections which could be
18 raised under the provisions of NRS Chapter 463; the State Gaming
19 Control Board having recommended that such Order be entered; and
20 good cause appearing therefore;

21 IT IS HEREBY ORDERED as follows:

- 22 1. That the licenses and findings of suitability hereto-
23 fore granted to Sam W. Klein be and hereby are terminated.
- 24 2. That Sam W. Klein shall resign as vice president and
25 director of Bally Manufacturing Corporation.
- 26 3. That Bally Manufacturing Corporation and its con-
27 trolled subsidiaries shall henceforth not employ Sam W. Klein in
28 any capacity.
- 29 4. That Sam W. Klein shall divest himself of the ap-
30 proximately 419,000 shares of stock of Bally Manufacturing Corpor-
31 ation owned by him according to the following schedule: 136,000
32 shares within one (1) year after the effective date of this Order

1 and all of the remainder within three (3) years thereafter.


2 5. That if any of said 136,000 shares of stock of Bally
3 Manufacturing Corporation remain unsold on the last day of the one-
4 year period following the effective date of this Order, Sam W.
5 Klein shall offer and Bally Manufacturing Corporation shall pur-
6 chase said shares or otherwise assure their purchase.

7 6. That Sam W. Klein shall forthwith execute an irrevoc-
8 able proxy to a person acceptable to the State Gaming Control
9 Board and the Nevada Gaming Commission to vote said 419,000 shares
10 of stock of Bally Manufacturing Corporation pending sale of the
11 shares.

12 7. That Sam W. Klein shall pay to the Nevada Gaming
13 Commission a fine in the amount of Fifty Thousand Dollars
14 (\$50,000.00).
