AMENDMENT NO. 4 TO ORDER OF REGISTRATION (BALLY MANUFACTURING CORPORATION) AND

AMENDMENT NO. 6 TO ORDER OF REGISTRATION (BALLY'S GRAND, INC.)

THIS MATTER came on for hearing before the State Gaming Control Board on August 8, 1986, and before the Nevada Gaming Commission on August 21, 1986 at Carson City, Nevada; and

THE BOARD AND COMMISSION having considered all information pertinent hereto;

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

THAT the application of Bally Manufacturing Corporation and Bally's
 Grand, Inc., as amended and supplemented, for modification of certain conditions

in their respective Orders of Registration, are hereby accepted as filed.

- THAT the conditions and restrictions set forth in paragraphs

 14(a), (c), (d) and (e) of Amendment No. 3 to the Bally Manufacturing Corporation

 Order of Registration, entered April 17, 1986, and paragraphs 9(a), (c), (d) and

 (e) of Amendment No. 5 to the Bally's Grand, Inc. Order of Registration entered

 April 17, 1986, are hereby rescinded.
- 3) THAT the conditions and restrictions set forth in paragraph 14(b) of Amendment No. 3 to the Bally Manufacturing Corporation Order of Registration and paragraph 9(b) of Amendment No. 5 to the Bally's Grand, Inc. Order of Registration are hereby rescinded and the following is substituted in lieu thereof:

Manufacturing Corporation or any of its subsidiaries other than Bally's Park Place, Inc. and Bally Warwick, Inc. during the pendancy of her application for licensing in the State of Nevada, nor shall Attanasio be physically present in Nevada during the time her application is pending unless consented to in advance by the Chairman of the State Gaming Control Board or his designee. Attanasio shall be specifically prohibited from exerting any influence over the affairs of Bally Manufacturing Corporation's Nevada gaming subsidiaries, either directly or through the use of any third party over whom she may influence or control, until her application has been favorably acted upon by the Nevada Gaming Commission.

4) THAT the above modifications to conditions on Orders of Registration for Bally Manufacturing Corp. and Bally's Grand, Inc. are further conditioned as follows:

Each licensed individual shall not contact, communicate, or deal with Dorothy Attanasio, either directly or indirectly, regarding the operations, affairs, or any other aspects of the Bally's Grand, Inc. Nevada gaming operations

without the prior written approval of the State Gaming Control Board Chairman or his designee until such time as Attanasio has been licensed or found suitable by the Nevada Gaming Commission.

- 5) THE COMMISSION hereby delegates to the Chairman of the State Gaming Control Board, or his designee, the authority to administratively approve any involvement by Dorothy Attanasio, which involvement would otherwise be prohibited in accordance with paragraph 3 above.
- 6) THAT except as expressly modified by this Amendment No. 4 to the Bally Manufacturing Corporation Order of Registration, and this Amendment No. 6 to the Bally's Grand, Inc. Order of Registration, or other Commission action, or
