17 THE APPLICANT having presented evidence and made arguments;

19 NO PERSON having appeared in opposition to the granting of  
20 the application as aforesaid; and

21 ON THE BASIS of the evidence submitted by the State Gaming  
22 Control Board and by the Applicant:

23 IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION,  
24 UPON CONSIDERATION OF THE RECOMMENDATIONS OF THE  
25 STATE GAMING CONTROL BOARD:

26 1. THAT the application, as supplemented and amended, of  
27 ALEXANDER WILMS for a state gaming license as an officer, director  
28 and controlling stockholder of Bally Manufacturing Corporation be,  
29 and the same hereby is, accepted as filed.

30 2. THAT the motion of ALEXANDER WILMS to withdraw his  
31 application be, and the same hereby is, granted; subject, however,  
32 to the following conditions:

(b) ALEXANDER WILMS shall resign immediately from any other offices or directorships or positions that he may hold with Bally Manufacturing Corporation or any of its subsidiaries; and


(c) Except as provided in subparagraph 2(a), ALEXANDER WILMS shall not seek any employment or engagement as an officer, employee or agent of Bally Manufacturing Corporation or any of its subsidiaries without prior approval of the Nevada Gaming Commission.
