AMENDMENT NO. 2 TO FOURTH REVISED ORDER OF REGISTRATION

THIS MATTER came on regularly for hearing before the State Gaming Control Board ("Board") on June 9, 1993, and before the Nevada Gaming Commission ("Commission") on June 24, 1993, at Carson City, Nevada; and

THE BOARD AND COMMISSION having considered all information pertinent hereto;

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

1. THAT the following applications, as amended and supplemented, are hereby accepted as filed:

a. The application of United Gaming, Inc. for an amendment to its Fourth Revised Order of Registration to allow its wholly-owned subsidiary APT Games, Inc. to be found suitable as the sole shareholder of Slot Palace, Inc. and that Slot Palace, Inc., db at Quality Inn & Casino be licensed to conduct nonrestricted gaming operation at 377 East Flamingo Road, Las Vegas.

b. The application of United Gaming, Inc. for an amendment to its Fourth Revised Order of Registration to allow its wholly-owned subsidiary, FCJI, Inc. to conduct

restricted gaming operations at One-Eyed Jacks #5, 1854 East Charleston Boulevard, Las Vegas, and at One-Eyed Jacks #6, 3220 North Jones Boulevard, Las Vegas.

c. The application of United Gaming, Inc. for an amendment to its Fourth Revised Order of Registration to allow FCJI, Inc. a nonrestricted gaming license (slot machines only) at One-Eyed Jacks #4, 2823 North Green Valley Parkway, #D, Henderson.

2. THAT paragraph 4 of the Fourth Revised Order of Registration of United Gaming, Inc. entered on October 28, 1992, is hereby rescinded and superseded in its entirety, and the following language is substituted in lieu thereof:

"4. THAT APT Games, Inc. is registered as an intermediary company and found suitable as the sole shareholder of United Coin Machine Co., APT Coin Machines, Inc., Mizpah Investments, Inc., Plantation Investments, Inc., Trolley Stop, Inc., WCAL, Inc. and Slot Palace, Inc."

3. THAT paragraph 11 of the Fourth Revised Order of Registration of United Gaming, Inc. entered on October 28, 1992, is hereby rescinded and superseded in its entirety, and the following language is substituted in lieu thereof:

"11. THAT FCJI, dba One-Eyed Jacks, Rebel Pub & Grub, One-Eyed Jacks #5, and One-Eyed Jacks #6 is licensed to conduct restricted gaming operations at 3740 South Nellis Boulevard, Las Vegas; 1131 East Tropicana, #G, Las Vegas; 1854 East Charleston Boulevard, Las Vegas; and 3220 North Jones Boulevard, Las Vegas, respectively. That FCJI, dba One-Eyed Jacks #4 is licensed to conduct nonrestricted gaming operations (slot machines only) at 2823 North Green Valley Parkway, #D, Henderson."

4. THAT the Fourth Revised Order of Registration of United Gaming, Inc. entered on October 28, 1992, is hereby amended by adding thereto the following new paragraph:

"24. THAT Slot Palace, Inc., db at Quality Inn & Casino, is licensed to conduct nonrestricted gaming operations at 377 East Flamingo Road, Las Vegas."

5. THAT except as expressly modified by this Amendment No. 2 to Fourth Revised Order of Registration, or other Commission action, all other terms and provisions of the Fourth Revised Order of Registration of United Gaming, Inc. entered on October 28, 1992, and Amendment No. 1 thereto entered on January 28, 1993, are hereby reaffirmed and incorporated by reference herein.
