AMENDMENT NO. 1 TO REVISED ORDER OF REGISTRATION

THIS MATTER came on regularly for hearing before the State Gaming Control Board on November 6, 1986, and before the Nevada Gaming Commission on November 20, 1986 at Las Vegas, Nevada; and

THE BOARD AND COMMISSION having considered all information pertinent hereto;

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

1) THAT the applications of Hilton Nevada Casinos, Inc. dba Las Vegas Hilton for a race book and sports pool, and of Hilton Hotels Corporation for an amendment to its Order of Registration, are hereby accepted as filed.

2) THAT paragraph 6 of the Hilton Hotels Corporation Revised Order of Registration dated September 18, 1986 is hereby rescinded and the following is substituted in lieu thereof:

That Hilton Nevada Casinos, Inc. is licensed as a manufacturer and distributor, and approved to continue nonrestricted gaming operations at the Las Vegas Hilton (including race book and sports pool), Flamingo Hilton and Reno

Hilton, subject to the following:

That the license issued to Hilton Nevada Casinos, Inc. to conduct gaming at the Reno Hilton is expressly conditioned upon the existence and maintenance of a pedestrian walkway linking the Reno Hilton at 241 North Virginia Street and 255 North Sierra Street and further, that said pedestrian walkway be open and accessible to the public during all times that gaming is conducted upon the premises of the Reno Hilton.

3) THAT the approval in paragraph 2 above related to the Las Vegas Hilton race book and sports pool is hereby conditioned that the surveillance system be reviewed and administratively approved by the State Gaming Control Board Enforcement Division prior to commencement of operations.


4) THAT except as expressly modified by this Amendment No. 1 to Revised Order of Registration, or other Commission action, all other terms and
