AMENDMENT NO. 9 TO ORDER  
OF REGISTRATION (HYATT CORPORATION)  
AND AMENDMENT NO. 6 TO ORDER  
OF REGISTRATION (ELSINORE CORPORATION)

THESE MATTERS came on regularly for hearing before the State Gaming Control Board on September 15, 1982, and before the Nevada Gaming Commission on September 23, 1982, at Las Vegas, Nevada.

THE APPLICANTS having presented evidence in support of their applications; and

NO PERSON having appeared in opposition to the granting of the applications; and

THE BOARD AND COMMISSION having considered the report of Investigation, Corporate Securities, and the evidence presented by the applicants;

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

1. THAT the application of HCC Corporation, as amended and supplemented, to be registered as an intermediary holding company and found suitable as a controlling

stockholder of Elsinore Corporation, is hereby accepted as filed.

2. THAT the applications to amend the Orders of Registration of Hyatt Corporation and Elsinore Corporation, are hereby accepted as filed.

3. THAT the approval granted in paragraph 9(b) of Amendment No. 7 to Order of Registration (Hyatt Corporation), and Order of Registration (Elsinore Corporation), dated December 15, 1978, whereby Hyatt Corporation was found suitable as a controlling stockholder of approximately twenty-seven percent (27%) of the outstanding shares of voting securities of Elsinore Corporation, is hereby rescinded and in lieu thereof the following is approved:

THAT HCC Corporation, a wholly owned subsidiary of Hyatt Corporation, is hereby registered as an intermediary holding company and found suitable to be a controlling stockholder of Elsinore Corporation and the following officers and directors are found suitable as indicated:

Harold S. Handelsman	Vice President, Secretary-Treasurer, Director

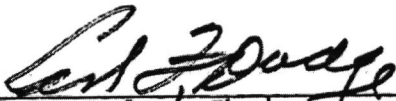
4. THAT Hyatt Corporation, a private intermediary holding company, is hereby found suitable to be the sole stockholder of HCC Corporation.

5. THAT except as otherwise expressly modified by this Amendment to Orders of Registration, or other Commission

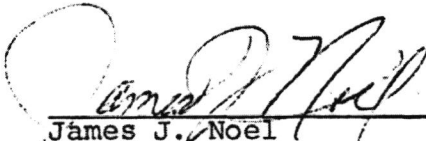
