AMENDMENT NO. 2 TO FOURTH REVISED ORDER OF REGISTRATION

THIS MATTER came on regularly for hearing before the State Gaming Control Board ("Board") on June 9, 1993, and before the Nevada Gaming Commission ("Commission") on June 24, 1993, at Carson City, Nevada; and

THE BOARD AND COMMISSION having considered all information pertinent hereto:

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

- 1. THAT the following applications, as amended and supplemented, are hereby accepted as filed:
- a. The application of Cardivan Company, db at Albertsons Store
 #637, for a nonrestricted gaming license (slot machines only);
- b. The application of Cardivan Company db at Albertsons Store
 #1621 for a nonrestricted gaming license (slot machines only);
 - c. The application of Cardivan Company db at Albertsons Store

#1616 for a nonrestricted gaming license (slot machines only);

- d. The application of Cardivan Company db at Albertsons Store #148 for a nonrestricted gaming license (slot machines only);
- e. The application of Jackpot Enterprises, Inc. for an Amendment to its Fourth Revised Order of Registration.
- 2. THAT paragraph 4 of the Fourth Revised Order of Registration of Jackpot Enterprises, Inc. entered on December 17, 1992, is hereby rescinded and superseded in its entirety, and the following language is substituted in lieu thereof:
- "4. THAT Cardivan Company is licensed as an operator of a slot machine route, and as a manufacturer and distributor, and that Cardivan Company, dba Cardivan Company at the following locations, is licensed to conduct nonrestricted gaming operations (slot machines only) at each of the following:

Albertson's #1621, 9200 West Sahara Avenue, Las Vegas;
Albertson's #1616, 3160 North Rainbow Boulevard, Las Vegas;
Albertson's #148, 195 West Plumb Lane, Reno;
K-Mart #3592, 5050 East Bonanza Road, Las Vegas;
Lucky Store #586, 4420 East Bonanza Road, Las Vegas;
Osco Drug Store #6, 285 East Plumb Lane, Reno;
Phar-Mor Drug Store #263, 4621 Fair Center Parkway, Las Vegas; and Sav-On Drug Store #224, 3550 West Sahara Avenue, Las Vegas."

3. THAT except as expressly modified by this Amendment No. 2 to Fourth Revised Order of Registration, or other Commission action, all other terms and conditions of the Fourth Revised Order of Registration of Jackpot Enterprises, Inc. entered on December 17, 1992, and as amended by Amendment No. 1 to Fourth

Revised Order of Registration entered on June 24, 1993, is hereby reaffirmed and incorporated by reference herein.
