ORDER OF REGISTRATION

THIS MATTER came on regularly for hearing before the State Gaming Control Board ("Board") on February 4, 2004, and before the Nevada Gaming Commission ("Commission") on February 19, 2004, at Carson City, Nevada; and

THE BOARD AND COMMISSION having considered all information pertinent hereto;

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE

RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

1. THAT the following applications, as amended and supplemented, have been filed:

a. The applications of Trump Hotels & Casino Resorts, Inc. for (i)

registration as a publicly traded corporation (ii) finding of suitability as the general partner of Trump Hotels & Casino Resort Holdings, L.P. (iii) finding of suitability as the sole shareholder of THCR Holding Corp, and (iv) finding of suitability as a beneficial shareholder of Riviera Holdings Corporation.

b. The applications of THCR Holding Corp. for (i) registration as an intermediary company, and (ii) finding of suitability as the sole shareholder of THCR/LP Corporation;

c. The applications of THCR/LP Corporation for (i) registration as an intermediary company, and (ii) finding of suitability as a limited partner of Trump Hotels & Casino Resorts Holdings L.P.;

d. The applications of Trump Casinos, Inc. for (i) registration as a holding company, and (ii) finding of suitability as a limited partner of Trump Hotels & Casino Resort Holdings, L.P.;

e. The applications of Trump Casinos II, Inc. for (i) registration as a holding company and (ii) finding of suitability as a limited partner of Trump Hotels & Casino Resort Holdings, L.P.;

f. The applications of Trump Hotels & Casino Resorts Holdings L.P. for (i) registration as a limited partnership, and (ii) finding of suitability as a beneficial shareholder of Riviera Holdings Corporation; and

g. The applications of Donald John Trump for a finding of suitability as a shareholder and controlling shareholder of Trump Hotels & Casino Resorts, Inc.

 THAT Trump Hotels & Casino Resorts, Inc. is registered as a publicly traded corporation, is found suitable as the general partner of Trump Hotels & Casino Resorts Holdings, L.P. and is found suitable as a beneficial shareholder of Riviera Holdings Corporation.

3. THAT THCR Holding Corp. is registered as an intermediary company and is found suitable as the sole shareholder of THCR/LP Corporation.

4. THAT THCR/LP Corporation is registered as an intermediary company and is found suitable as a limited partner of Trump Hotels & Casino Resort Holdings, L.P.

5. THAT Trump Casinos, Inc. is registered as a holding company and is found suitable as a limited partner of Trump Hotels & Casino Resort Holdings, L.P.

6. THAT Trump Casinos II, Inc. is registered as a holding company and is found suitable as a limited partner of Trump Hotels & Casino Resort Holdings, L.P.

7. THAT Trump Hotels & Casino Resorts Holdings, L.P. is registered as a limited partnership and is found suitable as a beneficial shareholder of Riviera Holdings Corporation.

8. THAT Donald John Trump is found suitable as a shareholder and controlling shareholder of Trump Hotels & Casino Resorts, Inc.

9. THAT within 30 days of the appointment of any officer, as defined by the Agreement of Limited Partnership of Trump Hotels & Casino Resorts Holdings, L.P., as amended, such officer shall file an application for a finding of suitability as a key executive.

10. THAT Trump Hotels & Casino Resorts, Inc., shall fund and maintain with the Board a revolving fund in the amount of \$25,000 for the purpose of funding investigative reviews by the Board for compliance with the terms of this Order of Registration. Without limiting the foregoing, the Board shall have the right, without notice, to draw upon the funds of said account for the payment of costs and expenses incurred by the Board and its staff in the surveillance, monitoring and investigative review of all activities of Trump Hotels & Casino Resorts, Inc., THCR Holding Corp., THCR/LP Corporation, Trump Casinos, Inc., Trump Casinos II, Inc., Trump Hotels & Casino Resorts Holdings, L.P. their subsidiaries, and their affiliated entities.

11. THAT pursuant to NRS 463.625, Trump Hotels & Casino Resorts, Inc., is exempted from compliance with NRS 463.585 through NRS 463.615, inclusive, and shall instead comply with NRS 463.635 through NRS 463.645, inclusive.

12. THAT Trump Hotels & Casino Resorts, Inc., is exempted from NGC Regulation15 and shall instead comply with the provisions of NGC Regulation 16.

13. THAT the Commission hereby expressly finds that the exemptions hereinabove granted are consistent with the State Policy set forth in NRS 463.0129 and NRS 463.489.
