#### 6.150 Minimum bankroll requirements.

- 1. The Chair may adopt or revise a bankroll formula that specifies the minimum bankroll requirements applicable to restricted gaming licensees, nonrestricted gaming licensees and persons [licensed] approved as an operator of an inter-casino linked system or <u>licensed</u> as an operator of a slot machine route, along with instructions for computing available bankroll.

Each restricted gaming licensee, nonrestricted gaming licensee and each person [licensed] approved as an operator of an inter-casino linked system or licensed as an operator of a slot machine route shall maintain in accordance with the bankroll formula adopted by the Chair pursuant to the requirements of this section, cash or cash equivalents in an amount sufficient to reasonably protect the licensee's or operator's patrons against defaults in gaming debts owed by the licensee or operator. If at any time the licensee's or operator's available cash or cash equivalents should be less than the amount required by this section, the licensee or operator shall immediately notify the Board of this deficiency and shall also detail the means by which the licensee shall comply with the minimum bankroll requirements. Failure to maintain the minimum bankroll required by this section, or a higher bankroll as required by the Chair pursuant to this section, or failure to notify the Board as required by this section, is an unsuitable method of operation.
