**TO:** All Group I and II Licensees, Restricted Licensees, and Interested Persons

**SUBJECT:** **Entertainment and Information Technology Minimum Internal Control Standards (V9) and Entertainment Internal Control Procedures (V3 and/or V4)**

---

As of June 1, 2023, all Group I licensees were required to comply with Version 9 of the Minimum Internal Control Standards (MICS). As of February 14, 2009, and July 1, 2024, all Group II and Restricted licensees were required to comply with Version 3 and Version 4 of the Internal Control Procedures (ICPs) respectively.

For Group I licensees – The Board is granting a variation to no longer require Group I licensees to comply with Entertainment MICS (V9) #2 - #9; #11 - #17; #19 - #20; #22; #26 - #30; and #32 - #35. Additionally, the variation is granted to no longer require Group I licensees to comply with the Information Technology MICS for Entertainment tax related applications.

For Group II and Restricted licensees – The Board is granting a variation to no longer require Group II and Restricted licensees to comply with Entertainment ICPs (V3) #3 - #9; #11 - #14; #18 - #23 and Entertainment ICPs (V4) #3 - #9; #11 - #20; #24 - #31. Additionally, the variation is granted to no longer require Group II and Restricted licensees to comply with the Information Technology ICPs for Entertainment tax related applications.

The variations are effective immediately. The written systems of internal control for Group I licensees should be updated no later than August 16, 2024.
