On or about September 24, 2004, the Nevada Gaming Commission approved the Final Stipulation for Settlement and Order between the STATE GAMING CONTROL BOARD (BOARD) and RESPONDENT settling the administrative complaint in the above-captioned matter.

On or about February 3, 2014, RESPONDENT filed an application requesting that the Final Stipulation and Order be amended with regard to certain requirements concerning Victor Bustos. The BOARD considered the matter on October 8, 2014. In consideration of the passage of time since the incident regarding Mr. Bustos with which the BOARD was concerned in 2004 and after investigation of Mr. Bustos and his activities subsequent to 2004, the BOARD finds the requested amendment appropriate.

THEREFORE, IT IS HEREBY STIPULATED AND AGREED to by the BOARD and RESPONDENT that the Final Stipulation for Settlement and Order, NGC Case No. 03-09, approved by the Nevada Gaming Commission on September 24, 2004, shall be amended as follows:

1. Paragraph 3 of the Final Stipulation for Settlement and Order, NGC Case No. 03-09 (Attachment 1), shall be deleted in its entirety.


2. All other provisions of the Final Stipulation for Settlement and Order remain in full force and effect.

1           3. RESPONDENT and the BOARD recognize and agree that the Nevada Gaming  
2 Commission has the sole and absolute discretion to determine whether to accept this  
3 Amendment to Final Stipulation for Settlement and Order. If the Nevada Gaming  
4 Commission does not accept this Amendment to Final Stipulation for Settlement and Order, it  
5 shall be withdrawn as null and void and the original, un-amended terms of the Final Stipulation  
6 for Settlement and Order (Attachment 1) shall remain in full force and effect.

7           4. This stipulated settlement agreement shall become effective immediately upon  
8 approval by the Nevada Gaming Commission.




