ORDER OF DENIAL

This matter having come on for hearing before the Nevada Gaming Control Board (Board) on April 7, 2016, in Carson City, Nevada, and on November 3, 2016, in Las Vegas, Nevada, on the above-captioned Applications and Request, with STEPHAN MICHAEL GALDAU having appeared with counsel William R. Urga, Esq., at the April 7, 2016 hearing, and without counsel at the November 3, 2016 hearing, and the Board having received and reviewed all information relative thereto;

AND WHEREAS the Board having denied with prejudice the Request to Withdraw Applications in accordance with Nevada Gaming Commission (NGC or Commission) Regulation 4.140;

AND WHEREAS the Board determined that STEPHAN MICHAEL GALDAU failed to satisfy the burden of proving his qualifications to be licensed as a Mem-

ber/Manager of SMG HOSPITALITY LLC, dba OWL, pursuant to Nevada Revised Statute (NRS) 463.5735(1) as required by NRS 463.170(1), (2), and (3)(a), NRS 463.339, and by NGC Regulations 3.090(1) and 4.040(1) and (2); and having specifically found:

- 1. STEPHAN MICHAEL GALDAU provided false testimony during the April 7, 2016 Board meeting in response to questions posed by the Board regarding his drug use history, as evidenced by the positive results from drug tests from hair samples obtained from STEPHAN MICHAEL GALDAU on or about March 3, 2016 and April 7, 2016, as well as testimony STEPHAN MICHAEL GALDAU provided during an interview conducted by Board agents on or about July 12, 2016 and at the November 3, 2016 Board meeting;
- 2. STEPHAN MICHAEL GALDAU has an extensive history of illegal drug use, as evidenced in part by the positive results from drug tests from hair samples obtained from STEPHAN MICHAEL GALDAU on or about March 3, 2016 and April 7, 2016, as well as his testimony provided at the public Board meetings held on April 7, 2016 and November 3, 2016, and during an interview of STEPHAN MICHAEL GALDAU conducted by Board agents on or about July 12, 2016;
- 3. Through his business dealings, STEPHAN MICHAEL GALDAU has demonstrated he does not possess the minimum level of business probity, competence and experience necessary to own and operate a licensed gaming establishment in the State of Nevada; and
- 4. Through his past conduct, reputation, habits and dealings with the Board, STEPHAN MICHAEL GALDAU has demonstrated that he is not a person of good character, honesty or integrity.

IT IS HEREBY ORDERED, upon unanimous vote, that a recommendation of denial of the Applications of SMG HOSPITALITY LLC, dba OWL for a Restricted Gaming License and STEPHAN MICHAEL GALDAU for Licensure as Sole Member and Manager of SMG HOSPITALITY LLC, dba OWL, be and is hereby issued to the Commission pursuant to NRS 463.1405(3) and NRS 463.210(3), said recommendation being based upon
