ORDER OF DENIAL

This matter having come on for hearing before the State Gaming Control Board (Board) on March 3, 2014, November 16, 2014, and May, 14, 2015, in Las Vegas, Nevada, on the above-referenced Applications and Requests and the Board having received and reviewed all information relative thereto;

AND WHEREAS the Board having granted without prejudice the request for withdraw of the Application of MIDTOWN LOUNGE LLC, dba MIDTOWN, for a restricted gaming license in accordance with Nevada Gaming Commission (NGC) Regulation 4.140;

1 AND WHEREAS the Board having granted without prejudice the request for withdraw
2 of the Application of COLETON DRAKE HANNA for licensure as a Member of MIDTOWN
3 LOUNGE LLC, dba MIDTOWN in accordance with NGC Regulation 4.140;

4 AND WHEREAS the Board having granted without prejudice the request for withdraw
5 of the Application of CHRISTOPHER JORDAN HANNA for licensure as a Member and
6 Manager of MIDTOWN LOUNGE LLC, dba MIDTOWN in accordance with NGC
7 Regulation 4.140;

8 AND WHEREAS the Board having granted with prejudice the request for withdraw of
9 the Application of ATOM GERALD MILLER for licensure as a Member and Manager of
10 MIDTOWN LOUNGE LLC, dba MIDTOWN in accordance with NGC Regulation 4.140;

11 AND WHEREAS the Board having denied the request for withdraw of the Application of
12 KEVIN MARTIN SCHANDA for licensure as a Member and Manager of MIDTOWN LOUNGE
13 LLC, dba MIDTOWN in accordance with NGC Regulation 4.140;

14 AND WHEREAS the Board determined that the applicant KEVIN MARTIN SCHANDA
15 failed to satisfy the burden of proving his qualifications to be licensed as a Member and
16 Manager of MIDTOWN LOUNGE LLC, dba MIDTOWN pursuant to Nevada Revised Statute
17 (NRS) 463.5735(1) as required by NRS 463.170(1), (2)(a), and (3), and by
18 NGC Regulation 3.090(1)(c); and having specifically found that the applicant KEVIN MARTIN
19 SCHANDA failed to prove himself to be a person of good character, honesty and integrity in
20 his business practices as a Member and Manager of MIDTOWN LOUNGE LLC, dba
21 MIDTOWN, particularly those practices related to his dealings with vendors, employees and
22 fellow investors thereof; and having further specifically found that the applicant KEVIN
23 MARTIN SCHANDA failed to prove that he has adequate business probity, competence, and
24 experience to own and operate a licensed gaming establishment within the State of Nevada.
25 Consequently, good cause appearing:

26 IT IS HEREBY ORDERED, upon unanimous vote, that a recommendation of denial of
27 the Application of KEVIN MARTIN SCHANDA for Licensure as a Member and Manager of
28 MIDTOWN LOUNGE LLC, dba MIDTOWN, be and hereby is issued to the NGC pursuant to


