The Board protects the integrity and stability of the industry through our investigative and licensing practices, and we enforce laws and regulations, while holding gaming licensees to high standards. Through these practices, The Board is able to ensure the proper collection of taxes and fees that are an essential source of revenue for Nevada.

#### **Position Description**

The engineer is under the administrative direction of a senior engineer and is responsible for evaluating gambling games, gaming devices, gaming associated equipment, cashless wagering systems, interactive gaming systems, race book and sports pool systems, and modifications thereto for regulatory compliance; performing forensic analysis in the investigation of patron complaints, disputes, or criminal allegations; analyzing technology as it relates to the gaming industry for suitability; performing statistical analysis of gambling games, gaming devices, and gaming associated equipment; developing computer programs to perform various functions related to the review of gaming technology; and performing related work as assigned.
