THE NEVADA GAMING CONTROL BOARD RELEASED FIGURES TODAY SHOWING THAT \$153.2 MILLION WAS WAGERED IN NEVADA'S 185 SPORTS BOOKS ON THIS YEAR'S SUPER BOWL.

NEVADA GAMING CONTROL BOARD CHAIRMAN KIRK HENDRICK SAID, "UNAUDITED FIGURES SHOW A SPORTS BOOK WIN OF \$11,287,594 WAS RECORDED ON WAGERS TOTALING \$153,183,002. THIS RESULTED IN A HOLD PERCENTAGE OF 7.4%."

CHAIRMAN HENDRICK ADDED, "THE NEVADA GAMING CONTROL BOARD LOOKS FORWARD TO ALLEGIANT STADIUM HOSTING SUPER BOWL LVIII IN LAS VEGAS NEXT YEAR."
