2025-03R: CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 5.200 REGARDING, WITHOUT LIMITATION, GAMING SALONS.

PROPOSED AMENDMENTS TO NGC REGULATION 5.200

PURPOSE: To modify financial criteria necessary to enter a gaming salon; to adjust the time period for which guests of a salon patron may remain in the gaming salon without the salon patron; to modify gaming salon logging and reporting requirements; to modify minimum wagers; to modify gaming salon supervision requirements; to require reporting regarding conduct in gaming salons; to allow the Board Chair to approve different financial criteria; to create requirements under which a gaming salon may be opened to the general public; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

The proposed regulation changes will be considered by the Commission in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally. Written comments should be submitted before 5:00 p.m., Tuesday, September 23, 2025, to the Board and Commission Executive Secretary via e-mail at regcomments@gcb.nv.gov.

These items will be heard by the Commission at its meeting on September 25, 2025, and may be continued and heard at subsequent meetings of the Commission as required to effectuate the above-stated purposes.
