2025-01R: CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATION 3 REGARDING, WITHOUT LIMITATION, REPEALING NGC REGULATION 3.060 CONCERNING FOREIGN GAMING.

PROPOSED AMENDMENTS TO REGULATION 3.060

PURPOSE: To amend NGC Regulation 3 by repealing NGC Regulation 3.060; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

2025-01R: CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATION 9.020 REGARDING, WITHOUT LIMITATION, ESTABLISHING THE PROCESS AND TIMEFRAME FOR ADMINISTRATIVE APPROVALS AUTHORIZED BY NRS 463.1725.

PROPOSED AMENDMENTS TO REGULATION 9.020

PURPOSE: To amend NGC Regulation 9.020 to provide the process by which a person may seek the administrative approval from the Chair of the Nevada Gaming Control Board (Board) provided in NRS 463.1725; To amend NGC Regulation 9.020 to provide the time period by which a person must seek the administrative approval from the Board's Chair provided in NRS 463.1725; To amend NGC Regulation 9.020 to clarify that the requirements set forth in the section apply to all licensed gaming businesses, not just to licensed gaming establishments; To amend NGC Regulation 9.020 to update and clarify the requirements relating to the estates of deceased or disabled persons; To amend NGC Regulation 9.020 to make various non-substantive edits to conform with current regulation formatting standards; And to take such additional actions as may be necessary and proper to effectuate this stated purpose.

The proposed regulation changes will be considered by the NGC in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally.

These items will be heard by the NGC at the February 27, 2025 meeting, and may be continued and heard at subsequent meetings of the NGC as required to effectuate the above-stated purposes.
